The Conference on Crimes Against Women (CCAW) launched the National Training Center on Crimes Against Women (NTCCAW) in 2023. NTCCAW allows CCAW to expand to year-round programming, broadening the ability to dive deeper into discipline-specific topics and increasing the opportunity to reach other disciplines such as healthcare, faith communities, and higher education.

The National Training Center (NTC) serves as an integral part of CCAW's mission to provide a national forum to disseminate the highest level of training. This is accomplished by providing progressive and advanced training from our array of subject matter experts that we have cultivated over the last two decades through the annual conference. NTCCAW offers a space for our state and national partner(s) to host events and trainings.

The Institute for Coordinated Community Response (ICCR) works alongside rural communities to improve their collaborative, systemic responses to domestic violence. Criminal justice practitioners from a rural community review current practices, learn from experts, and collaboratively implement changes to begin establishing an effective, sustainable Coordinated Community Response (CCR). This also includes a robust program comprised of quarterly in-person trainings hosted in a rural community.

In addition, ICCR provides training focused around the unique needs of rural communities on a national level. This is accomplished by providing free e-courses, virtual roll call trainings, monthly webinars, and a two-day virtual conference; Collaborative Responses to Domestic Violence in Rural Communities.

Since its inception in 2018, ICCR has worked solely with counties throughout Texas, however in 2023 ICCR was awarded funding from the Office of Violence Against Women (OVW) to expand its work to rural communities throughout the United States.

ON THE ROAD LENDING

On the Road Lending is a 501(c)3 nonprofit organization founded in 2013 that provides vehicle selection assistance and long-term financial mentoring to address a misunderstood, but substantial problem—providing a way for low-income individuals and families to overcome transportation barriers so they can get to work, lead healthier lives, and avoid predatory lending. On the Road Lending helps people improve their credit and purchase fuel-efficient, reliable cars, financing them through their sister private-equity loan fund with a low-cost loan.

Lack of reliable transportation is one of the reasons people lose their jobs. On the Road Lending helps people overcome this risk by finding them reliable cars that are affordable, under warranty, and fuel-efficient so they never have unforeseen, expensive car repair bills. They work with clients to build financial capability and then arrange an affordable loan. They stay with their clients for the life of the loan—usually five or more years—providing financial mentorship and support.

"I've really seen some amazing things since I started this company. Without fail, I have seen tears each time I deliver a car. These tears are tears of joy, relief, and gratitude. These are families who are amazed that someone would take a chance on them. I have seen people get raises and promotions because they could get to work on time. I have seen people whose children could go to better schools because their parents could get them there. I have seen families achieve economic mobility and better health. It is more than freedom of time, although that is critically important. I have learned that these families—my friends—love their cars in the same way I love mine."

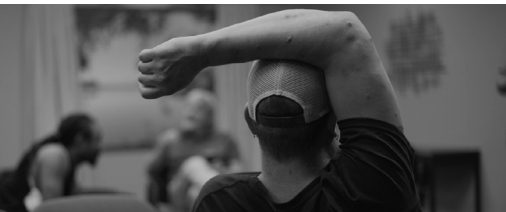

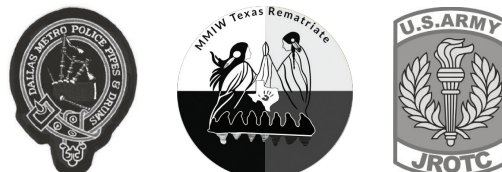

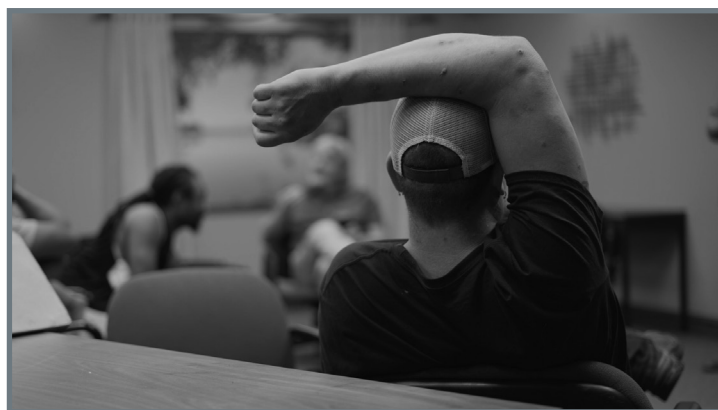

After surviving a life-threatening sexual assault in her hometown of Lindsborg, Kansas, college freshman Madison Smith and her parents were stunned when the local county prosecutor declined to file charges against the rapist, despite a strong case and compelling physical evidence. Traumatized by both the assault itself and her treatment by the police and prosecutor, Madison never wavered from the conviction that her attacker must be held accountable. She and her family refused to let the criminal justice system deny the facts and ignore her case, or to give up their quest for legal consequences.

In America, most female homicide victims are killed by their current or former partner and one in four women experience domestic violence or abuse. In this documentary Peabody and Emmy-winning filmmaker Deeyah Khan ask a simple question: is it possible to reduce these endemic levels of male violence? In search of an answer, she hears heartfelt testimonies from survivors and victims' families, and gets vital insights from social workers and psychologists who work with violent men. And she speaks to those whose voices are rarely heard in conversations about domestic violence yet hold the key to stopping it: the perpetrators themselves.

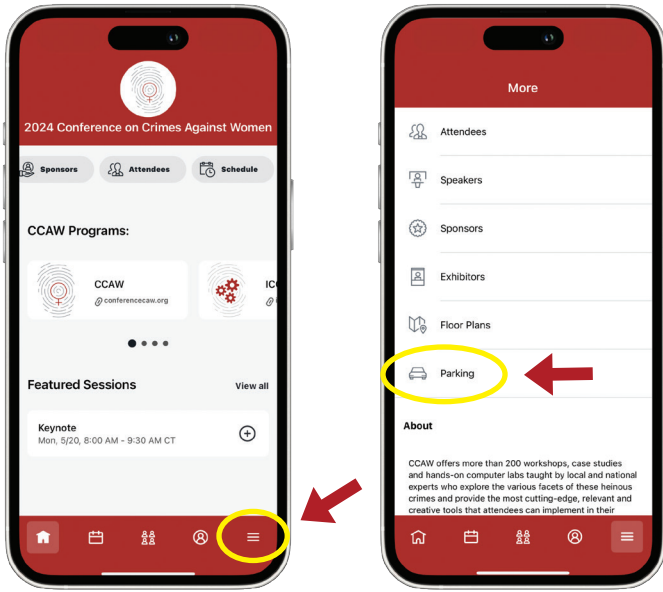

PARKING IN DALLAS



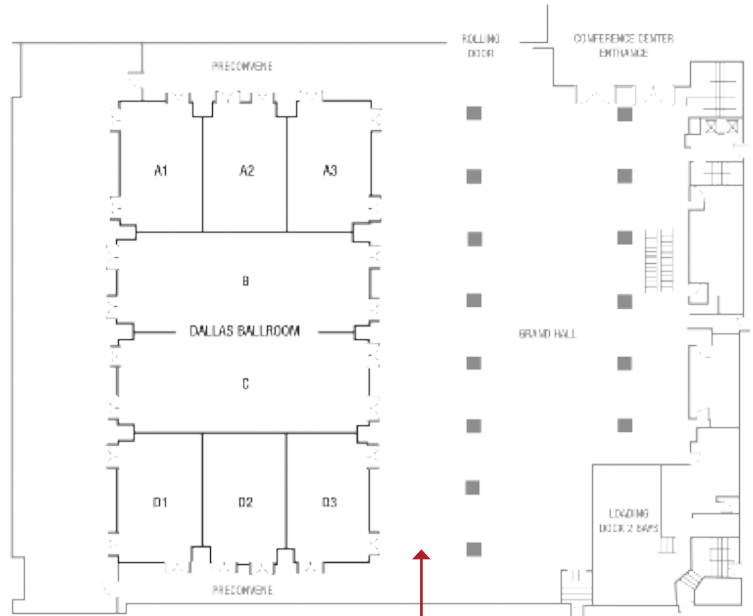

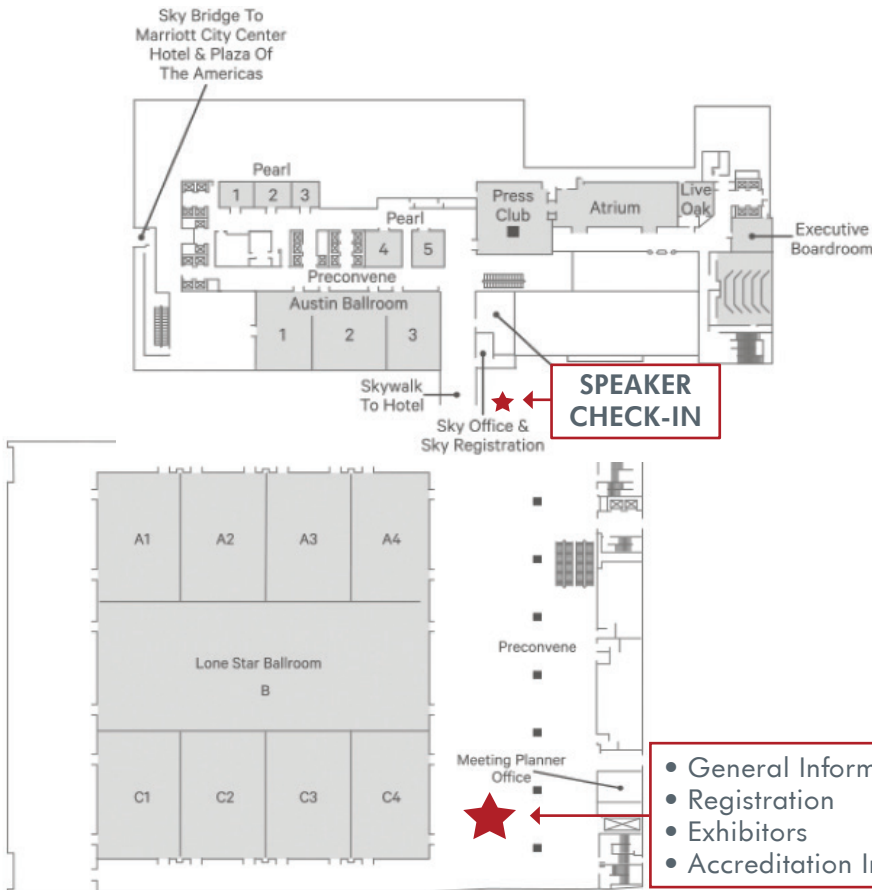

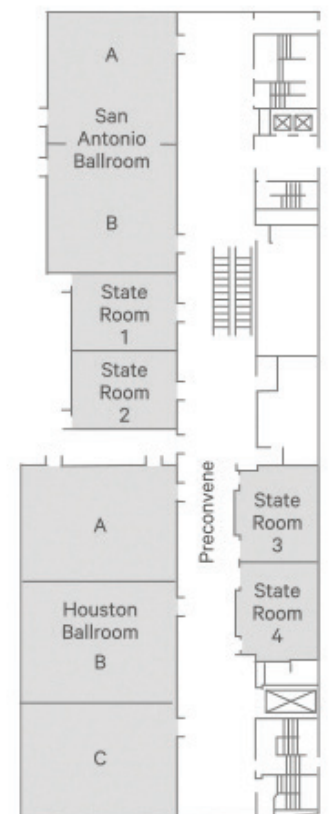
