Her 2009 memoir about surviving domestic violence, Crazy Love, was a New York Times Best Seller, People Pick, Book of the Week for The Week magazine, and subject of the first TED Talk by a domestic violence survivor. She lives in Washington, D.C.



# CASE STUDIES



# BARBER OF SAN MARCOS: A LESSON LEARNED ON JEALOUSY, SEXUAL ASSAULT, STRANGULATION, & WATERBOARDING + Allyson Cordoni, Brian Erskine, Janie Duke Mott

This case study will review the assault of a 34-year-old former U.S. Army soldier who was sexually assaulted in her own home and subjected to strangulation and waterboarding. This presentation will discuss the intense jealousy that the perpetrator exhibited towards the victim that lead him to beat, sexually assault, strangle, and waterboard her. While this case resulted in a conviction, there were several areas of investigation/examination that served as a teaching moment for all involved.

# DIRTY MONEY: AN FBI-HSI INVESTIGATION OF FOLK NATION/GANGSTA DISCIPLES' HUMAN TRAFFICKING ACTIVITIES Julio Lara

This joint FBI-HSI investigation provides a case study on the nexus between street gangs and human trafficking, with a discussion on how investigators can leverage social media and online activity to further cases. In this case, members of the Folk Nation/Gangsta Disciples street gang used force and coercion to prostitute women and children for member's own personal gain. Investigators used the gang member's online activity, social media presence, and use of interstate commerce to investigate and successfully prosecute six confirmed gang members, one of which was employed as a Juvenile Probation Officer. This case study highlights the success of interagency coordination and validates a victim-centered approach to human trafficking investigations.

# DOUBLE HOMICIDE IN BROOKLYN, TRIAL IN RUSSIA: A COLLABORATIVE PROSECUTION BETWEEN THE UNITED STATES AND RUSSIA

### Cynthia Lynch

This case study will present the investigation of a husband who brutally murdered his wife and her adult daughter in their Brooklyn, NY apartment, then fled to his native country, Russia, before he could be apprehended in the U.S. The U.S. and Russia do not have an extradition treaty, so prosecution by the Kings County DA's Office was not possible. The presentation will focus on the cooperative efforts of the Kings County District Attorney's Office, NYPD, Office of Chief Medical Examiner, U.S. Dept. of Justice, and the Russian police department and prosecutor's office to investigate, apprehend, and successfully prosecute the defendant in Russia.

# HUNTING THE RED BIRD RAPIST: HOW DALLAS CAUGHT & CONVICTED A PROLIFIC SERIAL RAPIST WITHOUT THE HELP OF FORENSIC EVIDENCE ♠

### Leighton D'Antoni, Amy Derrick, Todd Haecker

In 2013, Waldrick Brooks was a MMA fighter, husband, father, and video game enthusiast. He was a family man with no criminal history—but no one knew that over the course of the past three years, he had raped at least 16 young women. This case study will discuss how the Dallas PD used old-fashioned police work, without the help of any forensic evidence, to identify and arrest Brooks just one week after he raped his last victim. Prosecutors will focus on legal strategies used to admit evidence during the State's Case in Chief and how to win difficult sexual assault cases at trial with vulnerable survivors (prostitutes, drug addicts, and those with mental health issues).

#### THE INTERSECTION OF INTIMATE PARTNER VIOLENCE & HIV: ASSAULT WITH A DEADLY WEAPON +

### Tonia Cunningham, Curtis Howard, Diane Reeve

This case study involves a Frisco, TX man who intentionally transmitted HIV to his long-term partners and casual encounters. It provides a learning opportunity in a unique twist of IPV, as well as medical forensics in cases of HIV transmission. Extremely common, yet often ignored due to numerous obstacles investigative and prosecutorial issues, intentional HIV transmission and intimate partner violence are closely linked. Takeaways include the use of medical and community resources in obtaining evidence and unique investigative techniques. Presenters will discuss the integral role of medical science, best practices for media interaction in high-profile cases, the importance of recognizing symptoms of PTSD, and how advocates can contribute to the healing process in cases where victims have been betrayed as well as injured.

JACOB LEE BOYD: A STUDY IN TEEN VIOLENCE

#### Messina Madson, Jessica Trevizo

Jacob Lee Boyd was 17 when he strangled his 16-year-old girlfriend. The classmates that were initially outraged at the time of the murder appeared at trial to minimize the defendant's behavior and blame the victim. This case study will show how social media was used to shame a young girl and pressure her to stay in a relationship she was trying to leave.

### THE LISA CUTLER CASE: LESSONS LEARNED FROM A STAGED "DROWNING ACCIDENT"

### Nichole Kroncke, Andrea Zaferes

In 2012, Chad Cutler attempted to stage his wife's death as a "drowning accident" in their bathtub. Three years later, a jury determined Cutler had committed murder in a cold, calculated, and premeditated manner; he had intentionally drowned his wife after years of domestic violence. The ability of the Illinois State Police to perform a timely homicidal drowning investigation was key to a successful prosecution. Presenters will discuss how these challenging circumstantial cases can be worked from start to finish, with key takeaways including crime scene reconstruction and the use of expert testimony and hearsay statements by a deceased victim.

#### PROSECUTING THE BOY NEXT DOOR O

### Kara Comte, Jessica Escue

"He seemed like such a nice guy." As many in the law enforcement community know, some of the most dangerous and violent offenders are often wolves in sheep's clothing. These defendants often have minimal criminal history and are charming, personable, and outwardly safe. As a result, investigating and prosecuting these seemingly harmless defendants often presents unique challenges. This case study will focus on the investigation and prosecution of two offenders in a college town, Chad McFadden and Lance Leftwich, whose innocent appearances were key in allowing them to target their victims and nearly escape punishment.

# TOUGH DECISIONS: AN AGGRAVATED MALICIOUS WOUNDING CASE PROSECUTED AGAINST THE VICTIM'S WISHES ON Nancy Oglesby

C.A. was thrown through a double-paned window by her boyfriend, receiving life-threatening injuries. She was cooperative with the prosecution through the preliminary hearing until her boyfriend was released on bond. At that point, she hired an attorney to inform the Commonwealth that she would be "taking the fifth" and that she and her boyfriend were soon getting married. The presenter will show how this case was successfully investigated and handled in court despite several intentions to sabotage the matter. This case study will provide an in-depth look at how to build a successful evidence-based prosecution, even in the most serious cases, when the victim becomes a witness for the defense.

### U.S. v. MACIAS: MANIPULATION & CONTROL TACTICS OF A SEX TRAFFICKER

### Peter Angell

In July 2015, a mother and daughter entered a Police Department in Florida to report their fear of a man who had sexually assaulted the daughter and trafficked both women for commercial sex. In the 10-month investigation that followed, the FBI learned that a 35-year-old Army veteran had engaged in the sexual exploitation of numerous women around the U.S. for over a decade. The federal investigation resulted in the indictment and arrest of the trafficker on charges related to the interstate sex trafficking of a teenage victim, and in April 2016 he was sentenced to 30 years in prison. This case study will focus on the psychological tactics used by the trafficker to manipulate and control his victims and will also provide insight into the experiences of the trafficking survivor.

### WALKING IN HER SHOES (PART 1 & 2)

### Christi Decoufle, Leah Rogers

Through this case study and survivor story, attendees will better understand pimp culture as it applies to sex trafficking. The detective will outline a multi-state sex trafficking investigation with adult and juvenile victims. Participants will learn how the victim was coerced into prostitution; they will be shown how she was manipulated, controlled and exploited to financially benefit the trafficker and will understand the trauma inflicted and why a victim might not leave. The presenters will also discuss best practices in aftercare for service providers and investigators.

#### WHEN SERIAL RAPISTS MURDER +

### Fred Harris, Sheilah Priori

This case study will detail the investigation of a serial and savage sexual predator that viciously assaulted, robbed, and murdered his victims. One victim was found lying in pool of her own blood behind a building in Killeen, TX, left for dead. The victim was transported to the hospital for a forensic exam, which resulted in DNA collection that connected this predator to several rapes, robberies, serious assaults, and murder across two states. The presenters will discuss the medical aspect of the sexual assault exam and how law enforcement was able to build community trust and track a serial predator with the help of a forensic nurse, a brave woman, and a mother that refused to let her daughter's murder go unsolved.

# EXIF DATA & USB INFO: TAKING YOUR INVESTIGATION TO THE NEXT LEVEL

### Bryan Franke

This lab will introduce participants to EXIF data that can be found embedded within pictures. Learn what EXIF data is, what it contains, how to view it, how that data could enhance your investigation, and methods to document this information for the court, judge, and jury in an easily understood method. Ever wonder if someone has uploaded or downloaded information/programs/spyware via flash drive? Have they connected a "keylogger" to one of your USB ports? When you are executing a search warrant, would you like to know if the suspect has other storage devices or digital cameras you have not found, or connected their phone to the computer to download pictures? This session will give participants a software tool and hands-on application of it so you can quickly answer these questions while still on scene.

# FACEBOOK ADVANCED SEARCHING & URL MANIPULATIONS

### Dean Chatfield, Justin Fitzsimmons, Timothy Lott, Lauren Wagner

Facebook is the largest worldwide social media website and contains a substantial amount of potential investigative information. First, participants will use Facebook graph search to find a target profile. Once a target profile has been identified, we will use Facebook URL manipulations. URL manipulations can show content beyond what can be seen from going to the profile.

### **MUST-HAVE TECHNOLOGY TOOLS**

### Dean Chatfield, Justin Fitzsimmons, Timothy Lott, Lauren Wagner

This hands-on computer lab will include Firefox add-ons to save videos from YouTube and other websites, and to save or copy websites. Also included will be Google operators and services to make searching for information much for efficient and reliable, as well as Jing, VLC, Irfanview, and Audacity software.

### TRACING EMAIL COMMUNICATION

### **Bryan Franke**

When you are investigating a case that involves email, can you find out where it came from and what service and network was used to send it? Participants will learn how to locate, view, and read email header data. You will learn what resources are available to determine what Internet Service Provider (ISP) was used to send the email, how to locate where and how to serve preservation requests and legal process to said ISP, and what some email services do to change the email header data and how that impacts your investigation. Participants will also learn how to geo-locate a general area for the possible suspect before

Presenters will give examples of how collaboration has increased in Texas and how to replicate the collaboration model in attendees' communities and states. Coordinated community response models will include active duty, reserves, and veteran options.

# COORDINATED RESPONSE TO HUMAN TRAFFICKING: CLAIMING YOUR SEAT AT THE ANTI-TRAFFICKING TABLE

A survivor will take law enforcement inside the mind of a victim to explore the Illusion of Choice. Attendees will learn about trauma bonds and brainwashing, and will be able to answer questions such as, "Why don't they just run?" This advanced training will equip all areas of law enforcement and prosecution on trafficker's tactics, lingo interpretation and decoding online ads.

# IMMIGRATION & LAW ENFORCEMENT TOOLS FOR WORKING WITH VICTIMS O Natalie Nanasi, Jessica Salsbury

This workshop will provide an overview of the eligibility requirements for U nonimmigrant status and VAWA selfpetitioning, as well as discuss the benefits of each for both victims and law enforcement agencies. This workshop will also discuss the role law enforcement can play in providing evidence to support VAWA and U visas and address concerns surrounding providing certifications for U visas.

# IMMIGRATION Q&A: WHAT'S HAPPENING NOW?

# INTEGRATING IDENTITY THEFT SAFETY PLANNING INTO YOUR WORK WITH

The intersection between violent crime and identity theft may be more significant than many realize. This session will explore protócols that victim service professionals can implement to increase their organization's ability to provide assistance to survivors of both financial and violent crime, as well as steps organizations can take to train and collaborate with allied professionals.

### INTERGENERATIONAL TRANSMISSION OF TRAUMA: PARENT-CHILD DYNAMICS IN THE AFTERMATH OF HUMAN TRAFFICKING

#### Naomi Azar

This workshop will focus on the intersection of trafficking, trauma and parenting. It will consider ways in which a parent's trafficking experience might impact the parentchild relationship. Case examples will be presented in order to illustrate specific areas of vulnerability and to identify intervention options for caseworkers involved in a family system.

# **INTIMATE PARTNER CAMPUS HOMICIDES:** WHAT CAN WE LEARN ABOUT PREVENTION & EDUCATION?

This workshop will present the results of an analysis of campus homicides, focusing on common characteristics and danger signs. This workshop will analyze actual cases and provide suggestions for prevention and education.

# **INTIMATE PARTNER VIOLENCE & MILITARY** SEXUAL TRAUMA IN VETERAN TREATMENT COURTS O

#### Brian Clubb, Amanda Elkanick

Veteran Treatment Courts provide invaluable resources and treatment for veterans suffering from PTSD and TBI as a result of their service. It is becoming more common for intimate partner violence to be accepted into these courts. This workshop will focus on best practices for accepting these cases into VTC's, consideration of survivors through this process, and national and state resources.

#### INTIMATE PARTNER VIOLENCE IN A DIGITAL AGE

### Erica Olsen, Corbin Streett

This training will illustrate the safety risks of various technologies. Presenters will attendees to experience firsthand the hurdles discuss ways technology is misused to stalk, abuse, or harass survivors; how service providers can help victims assess the abuse that's happening; and offer suggestions on how to document or investigate technologyfacilitated abuse.

# INVESTIGATING INTIMATE PARTNER VIOLENCE IN THE LGBTQ COMMUNITY

Michael Crumrine

This workshop will focus on understanding and investigating intimate partner violence in the LGBTQ community and how to use best practices that encourage trust and respect. The presenter will discuss common myths and barriers, multidisciplinary solutions, and forensic interview techniques, as well as how to apply these practices in order to hold perpetrators accountable.

# INVESTIGATING WITH AN EVIDENCE-BASED PROSECUTION IN MIND + ©

Michael Milnor, Nancy Oglesby This workshop is taught by an investigator and prosecutor. It will cover specific methods of evidence gathering and corroboration, as well as trial preparation and presentation assuming the victim will not be a witness for the State. Evidence gathering even after the arrest and forfeiture by wrongdoing will also be discussed.

INVESTIGATION OF NON-STRANGER SEXUAL ASSAULT + ⊕ Michael Milnor, Nancy Oglesby

This workshop is taught by an investigator and prosecutor. Non-stranger sexual assault cases are some of the most difficult to investigate and prosecute because of the common "consent defense". The presenters will discuss the need for thorough corroboration, trauma-informed interviews, and specific ways to document the "no" message that was given by the victim. Corroborating alcohol-facilitated sexual assaults will also be covered.

# ISLAM, DOMESTIC VIOLENCE, & UNIQUE CONSIDERATIONS WHEN DEALING WITH **MUSLIM VICTIMS**

Omar Suleiman

This presentation will be an in-depth view of Islam's perspective on domestic violence from numerous angles. We will take a look at misconceptions as well as Islamic prescriptions for dealing with physical and emotional violence towards women. We will then look at unique considerations when dealing with Muslim victims and how to help Muslim women in abusive marriages.

# IT'S ABOUT CONTEXT, NOT CHARACTER: ADMITTING EVIDENCE UNDER R. 404(B) Jane Anderson, John Wilkinson

Prior or subsequent acts by an offender against the victim or others may provide compelling proof of motive, intent, absence of mistake or accident, identity, or a common scheme or plan to exploit a victim's vulnerability. This presentation will help prosecutors identify, and argue for the admissibility of, evidence under Rule 404(b).

#### IT'S ON US: CHANGING THE CULTURE Jenn Brown

It's On Us is a national movement to change the culture around sexual assault. This workshop will examine how It's On Us has combined grassroots organizing with national partnerships to educate, engage, and empower new allies on campuses and

communities nationwide. Attendees will develop a plan to bring It's On Us back to their campus or community.

#### LESSONS LEARNED FROM IMPLEMENTING THE BLUEPRINT FOR SEXUAL ASSAULT RESPONSE

The Blueprint for Campus Police, a policing tool designed to better serve victims and promote campus safety, was released in February 2016 by UT Austin's Institute on Domestic Violence & Sexual Assault. This workshop will present lessons learned from implementation across UT System Police departments and how it can be adapted for different campus and off-campus communities.

# LETHALITY ASSESSMENT PROGRAM, MARYLAND MODEL: SUCCESSES, IMPLEMENTATION, & BODY-WORN CAMERA CONSIDERATIONS

Kristine Chapman, Whitt Melton

The Lethality Assessment Program, Maryland Model is an evidence-based intimate partner homicide prevention protocol. Agencies in 37 states are implementing the LAF and include large cities, suburbs, small towns, and rural areas. This workshop will address how the program works, community preparedness for implementation, and guidance on the use of body-worn cameras during LAP administration.

#### LIVING WITH THE MEMORIES + Jim Tanner

Professionals working crimes against women see and hear many things that can have a disturbing effect on them and their families. This workshop will explain what's behind the secondary trauma of working. these cases and provide simple but effective steps we can take to help us live with these stories and images once we have seen and heard them.

# A LOOK AT CAMPUS SEXUAL ASSAULT & REPORTING REQUIREMENTS

Bronwyn Blake, Amanda Elkanick Campus sexual assault requires special consideration of reporting and response. In this workshop, attendees will learn basic dynamics of sexual assault and trauma, as well as the unique reporting requirements and legal rights of survivors on campus. Presenters will address the Clery Act, SAVE Act, and Title IX, as well as other options available to victims through civil legal services.

#### MINISTRY WITH SURVIVORS OF ABUSE: **BUILDING A PROGRAM IN YOUR FAITH** COMMUNITY

Jessica Brazeal, Hillary Owen

This workshop will provide practical steps to equip faith communities to respond to survivors of abuse. The presenters will share detailed steps on how Highland Park United Methodist Church began and expanded its domestic violence ministry. Attendees will be given the opportunity to collaborate, ask questions, and share best practices to develop action items for their own faith communities.

### MOBILE DEVICE EVIDENCE PRESERVATION & DATA EXTRACTION ©

John Day

This workshop will provide instruction on the preservation of digital evidence on mobile

device platforms and the various types of data extraction used today in criminal investigations. The presenter will display the various methods used by forensic examiners to extract data from mobile devices and best practices for preserving digital evidence.

# OFFENDER ACCOUNTABILITY: A SYSTEMS PERSPECTIVE

Jim Henderson

This workshop will discuss how our policies and practices can enhance or impede victim safety and offender accountability. Participants will learn about Therapeutic Jurisprudences, and the presenter will discuss similarities and differences between partner abuse and substance abuse, new tools for managing offenders, how enhanced community collaboration leads to community safety, and national resources for managing those charged with domestic violence.

#### ONE LOVE "ESCALATION" SCREENING Zoë Skinner

Join the One Love Foundation for a full 90-minute Escalation workshop. This filmbased workshop utilizes trained peerfacilitators to lead an open conversation about the difference between healthy and unhealthy relationship behaviors, providing tangible tools for students to standup for change. Following the film, the audience breaks into small discussion groups led by One Love trained facilitators.

#### ONE LOVE LUNCH: ESCALATION Zoë Skinner

Join the One Love Foundation for a lunch-time screening of their premier film, Escalation, and conversation about how the Foundation is building a movement to end relationship abuse through technologybased prevention tools. In opening people's eyes and sparking conversations, One Love is establishing stigma around abuse as the first ingredient in changing the horrible statistics.

### ONE SIZE DOES NOT FIT ALL: UNIQUE GUN SURRENDER SOLUTIONS

Rob Cañas, James Granucci, David Keck, Jennifer Waindle

This interactive panel will present several solutions for enforcing gun surrender laws: a judge-run program that uses private storage, a statewide surrender protocol, a protective order surrender program, and a probation-led solution in a state that doesn't have its own surrender laws. Attendees will have the opportunity ask questions and discuss ideas for leading a gun surrender effort in their own communities.

# ORDERS OF NONDISCLOSURE FOR SURVIVORS OF HUMAN TRAFFICKING ©

Natalie Nanasi

New laws in Texas and other jurisdictions have recently expanded eligibility for non-disclosure of criminal convictions for survivors of human trafficking. This session will provide information about the benefits and limitations of these laws, as well as resources to help advocates, attorneys, and others determine eligibility and navigate the application process.

# WORKSHOP DESCRIPTIONS

# OVERCOMING COERCIVE CONTROL IN INTIMATE RELATIONSHIPS (PT. 1 & 2)

#### Lisa Fontes

Coercive control is a strategy that some people use to dominate their intimate partners. Tactics include isolation, intimidation, manipulation, stalking, sexual coercion, and sometimes physical violence. Coercive control strips away a person's sense of self and basic rights. In this workshop, participants will examine coercive control and discuss ways to challenge it on personal, social, and professional levels.

# PARTNERING WITH THE NYPD: AN INNOVATIVE TRAUMA-INFORMED APPROACH AT THE PRECINCT LEVEL

#### Krista Ashbery, Maureen Curtis, Wanda Lucibello

Safe Horizon, together with the NYPD, has recently launched the Crime Victim Assistance Program. CVAP will place a domestic violence advocate and a generalist victim advocate in all New York City police precincts to provide trauma-informed client centered services. This workshop will discuss CVAP, its origins and implementation, and the potential impact on victim services and police/community relations.

# PIMP LIFE: THE ANATOMY OF A PIMP Cara Pierce

Do you think you can spot a pimp?
This workshop will explore the types of individuals involved in sex trafficking, as well as methods to identify pimps and sex

trafficking victims. It will also cover ways to work with and empower victims during investigations and prosecutions.

# POLISHING THE PROCESS OF TRAUMA-INFORMED NURSING +

### Rachel Fischer

This workshop will highlight best practices in building and maintaining forensic nursing programs, while differentiating hospital-based vs. community-based programs. The presenter will discuss ways to maintain program sustainability, including staff retention and combatting burnout due to vicarious trauma, as well as how to work collaboratively with community organizations to bridge the gap between competing and complementing agencies. Highlights from the Detroit Sexual Assault Kit project will also be discussed.

# PROSECUTING HUMAN TRAFFICKING CASES ♥

#### **Brooke Grona-Robb**

Human trafficking cases present prosecutors with unique issues and complicated litigation. This workshop is designed to assist prosecutors and investigators from initial investigation to post-conviction. It will discuss how to investigate cases to obtain successful prosecutions and will also review charging decisions, trial preparation, accomplice testimony, defense strategies, and witness preparation.

# PROTECTING YOURSELF IN A DIGITAL WORLD

#### Jim Tanner

Join a cybercrime analyst as he talks, in plain English, about the technical problems and risks everyone faces each time they log into their computer, use their phone, or use a credit card. Regardless of your technical expertise, you will walk away from this session knowing what to do to protect yourself and your family.

# RACE, CLASS, & GENDER: THE IMPACT OF GENDER ENTRAPMENT ON AFRICAN AMERICAN WOMEN

### Sharon Ellis Davis

African American female victims of domestic violence may not choose to report their abuse to the police, the church, or seek assistance from outside agencies due to the sordid history of oppression within African American communities. This workshop will bring awareness to the "Gender Entrapment" of African American women and work toward developing a culturally sensitive model of intervention with police and social services agencies.

# RAPE CULTURE IN AMERICA: REAL OR

### **Amy Jones**

This presentation will provide a definition for rape culture as a concept and offer a balanced look at the arguments currently being made for the usefulness of this concept when trying to understand the epidemic of sexual violence in our country.

#### SEX TRAFFICKING & TECHNOLOGY-FACILITATED CRIMES IN INDIAN COUNTRY

### Josefina Sabori

This workshop will explore the dangers faced by women in Indian Country that contribute to victimization through social media sites and technology-facilitated crimes. Participants will be able to identify indicators of sexual exploitation and trafficking based on case study of Native Americans.

#### **SEXUAL ASSAULTS ON CAMPUS**

#### **Gus Paidousis**

This workshop will cover a statistical overview of the scope and scale of sexual assaults on campus, as well as strengths and weaknesses of strategies to prevent and respond to their occurrence. Common challenges facing school administrations and law enforcement and the value of productive partnerships will be discussed.

### **SEXUAL DEVIANT KILLERS (PT. 1 & 2)**

#### Lawrence Simon

The evolution and unsettling features of violent sexual deviant pathology will be discussed. Participants will achieve a more comprehensive understanding of the overall mindset and outlook, fantasy facilitators, behaviors and etiology of violent sex offenders with the goal of identifying warning signs, interviewing suspects, increasing effectiveness in search warrants, and using greater case preparation from inception to closure.

# STALKING, INTIMATE PARTNER VIOLENCE, & ABUSE IN THE SOCIAL MEDIA AGE

#### **Elaina Roberts**

This workshop will focus on common ways stalkers misuse technologies, such as social media, smartphones, computers, cameras, and location-based services. It will give allied criminal justice professionals the tools they need to better work stalking cases, steps a victim can take to more safely use technology, and considerations for documentation and evidence collection.

# STRESS FIRST AID & EMOTIONAL SURVIVAL

#### Matt Hagan, Cliff Self

One-on-one or group interventions after dealing with traumatic events is important to keep first responders physically and mentally healthy. Studies have shown that those who are reluctant to seek psychological help are often willing to discuss issues with peer support teams. This fun, engaging workshop will cover the dynamics of dealing with traumatic investigations and how to emotionally survive the aftermath.

# SUCCESSFULLY IDENTIFYING & ACQUIRING ELECTRONIC EVIDENCE TO COMBAT THE CSI EFFECT

### Michael Crumrine

Given the common delays in reporting crimes of gender-based violence, non-traditional forms of evidence, such as electronic, must be used. This workshop will discuss tapping into the digital life of the offender, crafting search warrants for electronics, conducting pre-text communications, and other methods for electronic evidence collection. It will include examples of sanitized search warrants used in actual cases.

# SUFFER FROM BURNOUT? GIVE 'EM THE F.I.N.G.E.R.!

### Mark Yarbrough

The unhappiness and detachment burnout cases can threaten your job, relationships, and health. Participants will learn the definition and symptoms of burnout while laughing and learning how to apply the presenter's F.I.N.G.E.R. philosophy to help themselves and their co-workers avoid and/or recover from burnout.

# TAKE OUT THE DRAMA, BRING IN THE TRAUMA: HOW TO CONVERT CHALLENGES INTO CONVICTIONS ©

### Kelsey McKay, Russell Strand What impact does trauma have on

What impact does trauma have on whether a violent crime is taken seriously, documented, investigated, or prosecuted? The answer may surprise you. Information that may not make sense and is often misinterpreted can be valuable if understood and translated. This workshop provides information about common red flags and discuss strategies to enable a better analysis of these complex cases.

# TAKING ON THE TOUGH SEXUAL ASSAULT CASE: MOVING BEYOND UNREASONABLE DOUBT ©

Russell Strand

This workshop will focus on symptoms that indicate brain-based responses to fear and trauma to better clarify whether aspects of a report being viewed as unreasonable doubt are, in fact, evidence of a crime. Balancing the totality of the case against an accurate set of metrics provides the framework to either prove "positive evidence" or disprove "negative evidence."

# TELL ME HOW YOU REALLY FEEL: JURY SELECTION IN CASES INVOLVING CRIMES AGAINST WOMEN ©

Tiana Sanford

An attorney may receive mere minutes to educate and influence a potential juror, compared to the hours that individual is being influenced by their environments and the people in them. This workshop will explore critical differences in jury selection for cases involving crimes against women and effective strategies for identifying juror bias and solidifying desired jurors.

TITLE IX INVESTIGATIONS 101

**Brandy Davis** 

In this workshop, attendees will learn the "who, what, why, and how" of the Title IX investigation and adjudication process, from intake to resolution, incorporating legal requirements and institutional best practices. The presenter will also address the significant differences between criminal and Title IX definitions and procedures.

# TRANSLATING DOUBT INTO CONVICTION THROUGH THE STRATEGIC USE OF EXPERT WITNESSES (PART 1 & 2) ③

Margaret Bassett, Noël Busch-Armendariz, Melissa Hamilton

This two-part workshop will provide guidance on when and how to use expert witnesses to help fact finders view interpersonal crimes through the correct filter necessary to turn "weaknesses" into evidence of a crime. Participants will develop strategies to address common themes, safety, and risk assessment.

# UNDERSTANDING & INVESTIGATING TECHNOLOGY MISUSE

Bryan Franke, Erica Olsen

Offenders often misuse technologies and online spaces as tactics of abuse. Helpful for criminal justice professionals as well as service providers, this session will discuss offenders' tactics, how survivors can document the abuse, and how law enforcement can collect evidence and pursue cases.

#### UNDERSTANDING THE CRIME SCENE IN **NON-FATAL STRANGULATION CASES** (3 HR.) 🖸

Casey Gwinn, Kelsey McKay, Jamie Slaughter, Bill Smock

In this mock scenario, participants will investigate a non-fatal strangulation case. They will work collaboratively to gather hard-to-detect evidence, build a case, and practice interviewing the witness and investigating the crime scene. It will conclude with a summary of tips for improving your investigation for felony prosecution. This session will be limited to 50 attendees in order to provide a hands-on, interactive experience.

#### THE UNIDENTIFIED VICTIM ON PROBATION

Jim Henderson

Probation, parole, and pre-trial services professionals can play an important role in identifying and addressing the needs of IPV victims under community supervision and recognize unreported cases. The presenter will discuss risk factors, sample screening questions/tools, and supervision strategies. Attendees will also learn to identify collateral contacts and other data that can be useful when seeking to identify IPV victims.

#### UNMASKING THE SEXUAL OFFENDER (PT. 1 & 2)

Veronique Valliere

Sexual offenders present difficult and complicated issues in treatment and management. Traditional approaches are not only ineffective, but can replicate the offense dynamics and increase risk to the community. Participants will develop an understanding of sexual offense dynamics and an acceptance of the worldview of the offender. An exploration of the distortions, fantasies, and interpersonal manipulations will be presented.

# USING DIALECTICAL BEHAVIOR THERAPY SKILLS WITH VICTIMS OF VIOLENCE

Michele Galietta

Dialectical Behavior Therapy is a cognitive-behavioral intervention that may be useful to those working with individuals who have experienced severe violence or trauma. Trauma robs someone of a sense of wellbeing, and DBT uses mindfulness to restore that sense of safety. Other skills in DBT teach strategies for coping with painful emotions, tolerating distress, and managing relationships.

# USING NEUROFEEDBACK TO TREAT DOMESTIC VIOLENCE BRAIN INJURIES Joshua Brown, Peggy Wright

Recognizing that traumatic brain injury could greatly interfere with an abuse ' survivor's goal of achieving self-sufficiency, the Fort Bend Women's Center began a neurofeedback program that has had promising results. Participants of this workshop will be presented with relevant overviews of TBI, IPV, and neurofeedback, including a live neurofeedback demonstration.

# VOLUNTARY INTOXICATION: IT'S NOT CONSENT FOR SEX, YOU KNOW!

Russell Strand

Sexual assault investigations and prosecutions involving voluntary intoxicated victims present significant challenges. This workshop will provide participants with a strong foundation in the toxicology of alcohol and how to investigate to identify the outward manifestations of the impact of alcohol, as well as its impact on decisionmaking, memory, and perception.

# WALKING THE LINE: ASSISTING VICTIMS OF VIOLENT CRIME & SUPPORTING INVESTIGATORS ©

Peter Angell, Jennifer Romero

This workshop will discuss the vital role that victim advocates play not only in assisting victims and facilitating the recovery process, but also in supporting the investigation and prosecution when working as a team with agents and prosecutors. An FBI Victim Specialist and Special Agent will share best practices and lessons learned from years of experience.

# WHAT YOU SHOULD EXPECT FROM AN EFFECTIVE ON-SCENE INVESTIGATION

Mark Wynn

Through the use of interactive participation, case studies, and re-enactments, the participants will view the incident and crime scene through the eyes of the investigating officer. On completion of this workshop, participants will understand the five objectives of an on-scene investigation, interviewing techniques, victim behaviors, and offender motivation.

# WHY VIOLENCE HAPPENS WHEN VETERANS COME HOME: VETERAN, **SPOUSE & LEGAL PERSPECTIVES** PT. 1 & 2

Anne Jackson, Michael Jackson

Lt. Col. Jackson will provide a candid discussion of his deployments, their effect on him and his family, and his continued challenges with the lingering effects of service. Mrs. Jackson will discuss her experiences as a spouse, mother, and prosecutor of military family violence to distinguish traditional family violence power and control models from typical post deployment behaviors.


