The Conference on Crimes Against Women (CCAW) launched the National Training Center on Crimes Against Women (NTC) in 2023. NTC allows CCAW to expand to year-round programming, broadening the ability to dive deeper into discipline-specific topics and increasing the opportunity to reach other disciplines such as healthcare, faith communities, and higher education.

The National Training Center serves as an integral part of CCAW's mission to provide a national forum to disseminate the highest level of training. This is accomplished by providing progressive and advanced training from our array of subject matter experts that we have cultivated over the last two decades through the annual conference. NTC offers a space for our state and national partner(s) to host events and trainings.

The Institute for Coordinated Community Response (ICCR) works alongside rural communities to improve their collaborative, systemic responses to domestic violence. Criminal justice practitioners from a rural community review current practices, learn from experts, and collaboratively implement changes to begin establishing an effective, sustainable Coordinated Community Response (CCR). This also includes a robust program comprised of quarterly in-person trainings hosted in a rural community.

In addition, ICCR provides training focused around the unique needs of rural communities on a national level. This is accomplished by providing free e-courses, virtual roll call trainings, and monthly webinars.

Since its inception in 2018, ICCR has worked solely with counties throughout Texas, however in 2023 ICCR was awarded funding from the Office of Violence Against Women (OVW) to expand its work to rural communities throughout the United States.

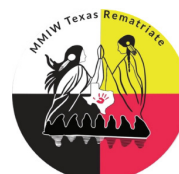

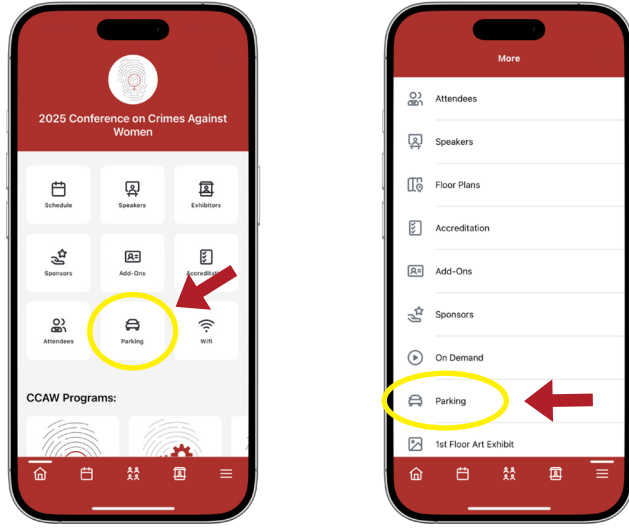

## PARKING IN DALLAS

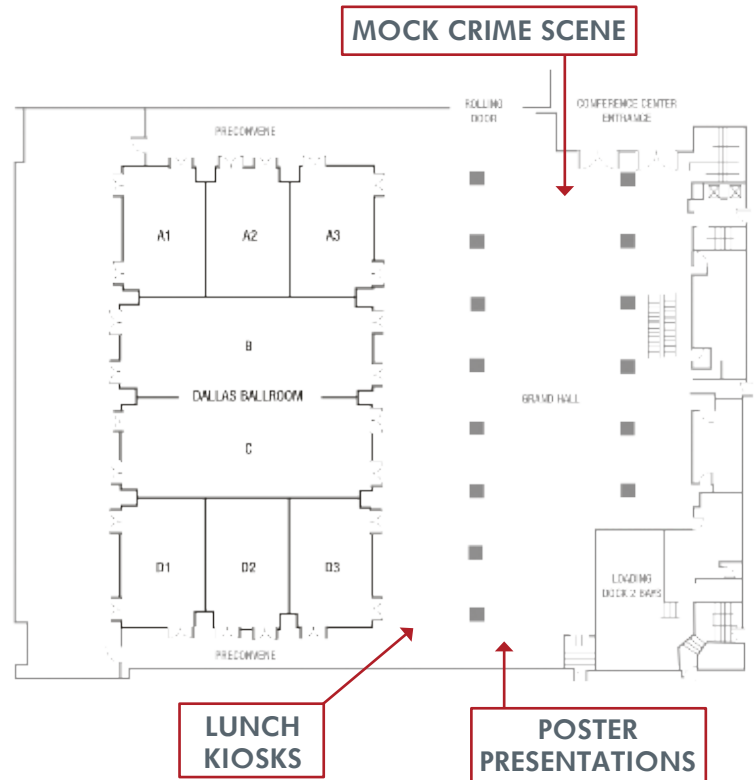


Navigate to the Conference App to access a list of parking lots nearby.

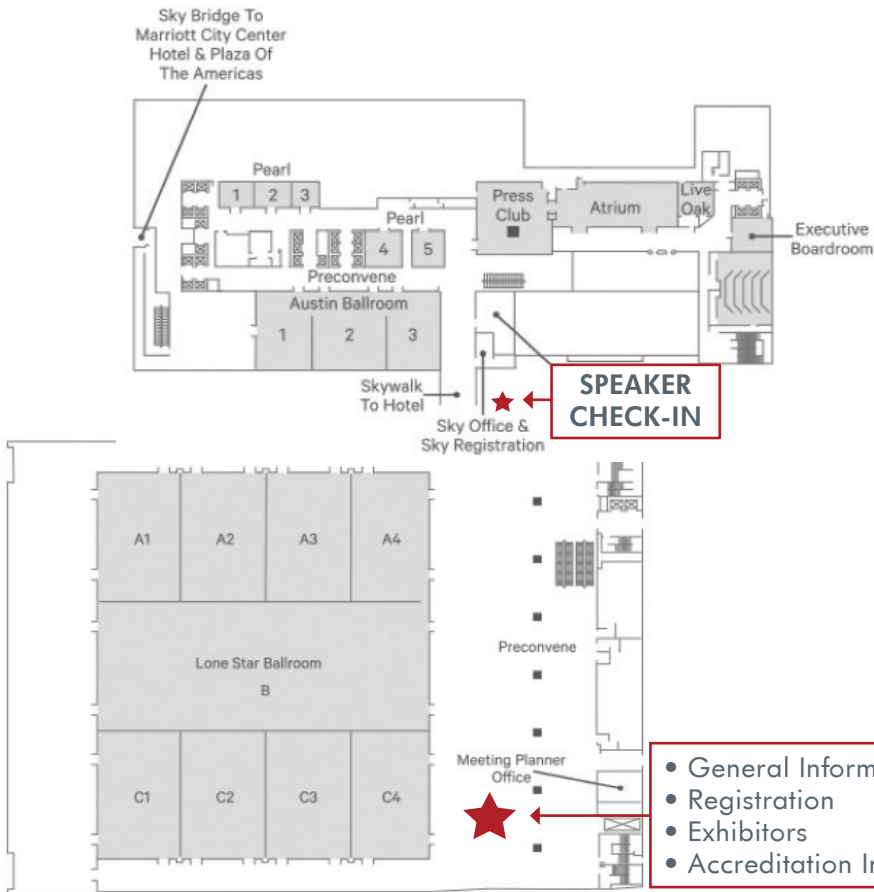
Follow the steps below:
